Dear Ms. Kato:


This office represents the County of Orange and its Board of Supervisors. We are writing in response to your letter of October 5, 2010, which we are treating as a Public Records Act request. Brad Gross, Director of the Dana Point Harbor Department, received your letter on October 7, 2010.

The date for response to your request is extended, pursuant to Government Code section 6253(c), for the following reasons:

- (1) The need to search for and collect the requested records from other County departments that are separate from the Dana Point Harbor Department; and
- (2) The need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records that are demanded in your request; and
- (3) The need for consultation, which will be conducted with all practicable speed, with other agencies and offices having substantial interest in the determination of the request.

We expect to dispatch a determination of your request on or before November 1, 2010. However, we understand that you and Mr. Gross have agreed that copies of the actual records will be provided to you on or about November 30, 2010.
